Subject: Allotment of HSAM Board's Houses.

In its 192nd meeting held on 28.2.2011, the Board vide Resolution No. 13 has resolved to replace the following existing pay structure with the following for allotment of houses:

| Type Of Houses | Plot Area | Pay scale for House entitlement |
|----------------|-----------|--------------------------------------|
| 1 | 2 | 3 |
| 'C' | 387 Sq.yd | PB-3 Rs. 15600-39100+6000 GP & above |
| 'D' | 250 Sq.yd | PB-2 Rs. 9300-34800+4200 GP & above |
| 'E' | 151 Sq.yd | PB-2 Rs. 9300-34800+3200 GP & above |
| 'F' | 118 Sq.yd | PB-1 Rs. 5200-20200+1900 GP & above |
| 'G' | 96 Sq.yd | PB-1 Rs. 4440-7440+1300 GP & above |

The above change in entitlement will come into force with immediate effect.

Other terms and condition of Haryana State Agricultural Marketing Board Houses Allotment Rules, 1999 will remain unchanged.

It has also been decided that those employees who have their own houses at Panchkula/Chandigarh will pay house rent as per rules/instructions of the Haryana Government.

The Board vide its Resolution No. 6 dated 30.6.1997 has also decided that as per instructions contained in Government letter No. A-5/96-5729-5800 dated 20.6.1996 (copy enclosed), the employees who have their own houses at Panchkula, Mohali & Chandigarh and have occupied Govt. accommodation, the recovery of licence fee be made in double. Option in this regard be obtained from the Govt. employees whether they will vacate the Govt. accommodation or pay the double licence fee. This Govt. decision was also conveyed by this office vide letter No. PD-297/57773-930 dated 09.09.1997 to all the Z.ME.Os, D.M.E.Os, E.O-cum-Secretary in the State and CFA, HSAM Board, Panchkula. All Branch incharge at H.Q Panchkula are requested to send their action taken report in this regard.
