- The cost of tender more than Rs.50.00 Lacs will be opened in the office of Superintending Engineer, HSAM Board Gurugram.
- The payment of tender document fees, E-service fee and earnest money received through demand draft in favour of "Executive Engineer HSAMB (Earnest Money) Gurgaon" and submit of demand draft on 18.12.2019 (9:00 AM to 12:00 PM) in Division office. The documents of bid will be received only on-line and no paper document will be received manually.

**CONDITIONS:-**

- If the prescribed date happens to be public holiday then the next working day shall be treated as date of opening of bid.
- The bidder shall have the ownership of hot mix plant and paver finisher for special repair of link roads.
- The Un-Employed Graduate Engineer is required to deposit 1% earnest money.
- The L & C Societies are required to deposit 1% Earnest Money on the production of the requisite certificate.
- All the bids shall remain valid upto 90 days from the opening of the financial bids. Earnest money will not be released before 90 days or allotment of work whichever is Earlier. This condition will also be applicable in case of non-submission of bid.
- Telegraphic/ambiguous tender involving time and financial implication shall not be accepted.
- The details of work i.e. estimate DNIT, drawing and other conditions can be seen in the office of the undersigned on any working day during the office hours.
- The undersigned reserves the right to reject any or all tenders without assigning any reason.
- 10% security shall be deducted from each running bills of the agency, subject to condition that overall amount of security should not exceed 5% of agreement amount and the security shall be returned as per CA Board office letter No. **05806-40 dated 18.06.2015**.
- Any type of rebate offered by any agency will be treated as unconditional.
- All Taxes will be applicable as per Govt. instruction.
- The agencies enlisted with PWD (B & R) PWD (Public Health), PWD (Irrigation), HUDA, HSIDC, Power Utilities and Railways are also eligible to put in their tenders in HSAMB under appropriate class of their enlistment after depositing one time prescribed enlistment fee in the Board.
- It has been decided that henceforth defect liability period for various development works such as construction of new link roads, special repair of roads (where the provisions of repair are taken in whole length) and new building works may be taken as 3 years. For implementation and proper maintenance of these works, following additional conditions / requirements may be incorporated in the DNITs of all the works in future.
- To qualify for award for the contract, each bidder in his name should have in the last five(5) years satisfactorily completed one similar work costing not less than 40% or two similar work costing not less than 33.3% or three similar works costing not less the amount 25% of the estimated cost. The cost of work shall mean gross of the completed work including the cost of materials supplies by the HSAMB but excluding those supplies fee of cost. They should be certified by an officer not less than the rank of Executive Engineer or equal".

The performance security equivalent to 5% (for Contactor / Agencies & 2.5% for societies) value of the agreement amount shall be provided in the form of "on demand Bank Guarantee" denominated in Indian Rupees issued by a Nationalized Bank to the employer not later than 21 days from the date of allotment or date specified in the letter of acceptance. The Bank Guarantee shall be valid up to 28 days from the expiry of defect liability period. All EE's must ensure revalidation of the Bank Guarantee in case of delayed projects. If the agency fails to submit the required Guarantee and execute agreement within 21 days of the allotment then the earnest money deposited by him shall be forfeited (vide CA Office letter no.05806-40 dated 18.06.2015 & No.1063-97 dated 09.02.2016).
