The HSAMB intends to develop an Ultra Modern Apple, Fruit and Vegetable Market at Pinjore in an area of 78.33 Acres. This market will be the biggest & specialized Apple Wholesale market of the country with the latest state of art modern infrastructure, technology and computerized management systems. To increase the income of the farmers and transparent trading, this market will function on e-trading platform. Market will operate on a hub and spoke model and will act as a regional collection centre for major fruits & vegetables grown by the farmers in the region and other parts of the country. This market will also be hub for the off-season and exotic vegetables and will focus on the large volumes of tomato trade.

To kick start trading activities on the premises and aiming at making this market an international level trading hub for Fruits & Vegetables especially for Apple Trade, Haryana State Agricultural Marketing Board (HSAMB), a Haryana State Government Organization invites Expression of Interest (EOI) & applications from the Apple Traders / Buyers from Panchkula, Chandigarh, Himachal Pradesh and Jammu & Kashmir who are eligible as per the eligibility criteria of this EOI.

Eligibility Criteria

1. Minimum Four years of experience in Apple Trade, out of which two years of experience should be in last five years (Starting from 1st of July 2015 to 1st July 2020);
2. Minimum Rupees 50 Lakh per annum of Apple Trade (duly verified by Chartered Accountant).

Submission of Expression of Interest:- The interested agencies as specified in eligibility criteria may submit their Expression of Interest addressed to The Chief Administrator, Haryana State Agricultural Marketing Board along with the details of their profile, audited financial report and expertise, in the office of Chief Marketing Enforcement Officer, C-6, Sector-6, Panchkula (Haryana) by 17.07.2020 by 01.00 P.M.
