Terms & Conditions

1. Project Duration:-

The project is proposed for duration of 12 months with start date

2. Scope of Work: -

- i. HSAM Board, Panchkula will develop one sanitation park in each 40 Fruit
 & Vegetable Markets under e-NAM Project.
- ii. The firm will deploy 20 Project Coordinator, 40 APMC Coordinator and 40 IEC/BCC and capacity Building Specialist at total location. For each location, the total resources deployed will be as follow:
 - 4. 20 Project coordinator (Need based)
 - 5. 20 Project In charge (Dedicated)
 - 6. 40 Dedicated Manpower
- iii. Natural leaders at the APMC level will be identified and nurtured to promote and encourage collective action.
- iv. HSAM Board, Panchkula will not consider the firm as employee.
- v. HSAM Board, Panchkula will not be liable for negligent, willful act or conduct of the firm.

3. Financing Model:

- i. To be submitted at the time of submission of documents.
- ii. Revenue generated from the MRF site (user fee and sale from recyclables) will be handed over to HSAM Board after one-year operations.
- iii. The financial sustainability of the project i.e. operating cost met from the circular economy, will be attained within a span of 1 year after the sanitation parks become operational. Considering full-scale operation of the project, the project will become self-sustaining from ______. The surplus revenue generated from the circular economy will also recover the capital investment within 2-3 years.

4. Support from APMCs of HSAM Board:

- i. Land is provided for development of a sanitation park in each APMC after proper leveling and clearance of debris and land filling.
- ii. HSAM Board will arrange a meeting with the existing SWM vendors operating in each area/site.
- iii. Provide waste and electricity point at the sanitation park.
- iv. Organize review meeting fortnightly to discuss project development activities quarterly.
- v. Provide segregated waste at sanitation by Safai Karmi.

vi. Depute APMC staff at regular intervals to understand the processes so that deputed staff of APMC takes over the system upon exit of the agency.

5. General Terms & Condition:-

- i. The period of the contract will be for 12 months or till the time the concerned APMC has its Solid Waste Management Plant operational, whichever is later as per above financial model.
- ii. The Agency has to do the work strictly as per specification and further during the inspection of work/testing at any time in future by any Govt.

 Department/agency. If any deficiency in the work is noticed the agency will be responsible. The Agency is liable to pay for any recovery if found against Agency due to deficiency in the work executed by that Agency.
- iii. The APMC will clear all existing Dumping points which are already created in the Mandi complex.
- iv. The Agency scope of work can be increased/decreased depending upon the performance, at any time by the competent authority of HSAM Board.
- v. The Agency has to start the work the work within 15 days from the date of issuance of the work order and sign an agreement with the concerned Secretary APMC within 30 days of this work order containing detailed terms & Conditions.
- vi. The processing plant/ site can be inspected by the officers/ officials appointed by the competent authority at any point of time.
- vii. GST, Pan No. should also be submitted by the agency. Income Tax will be deducted from the bills of agency as per the Income Tax Act.
- viii. The agency will maintain daily log book based on compost generated and copy of the same will be handed over to APMC on monthly basis.
- ix. The agency will provide the safety gear equipment/ PPE to all their employees working at the processing plant as per decided parameter, failing which necessary action will be initiated.
- x. In case of any dispute, the decision of Worthy Chief Administrator HSAM Board, Panchkula will be final and binding on the agency.
