**Subject : Constitution of Flying Squads- Inspection of all Kharif crops including Paddy and Cotton in the Mandis.**

In order to effectively implement the provisions of the HAPM Act, 1961 and (General) Rules, 1962 and check the evasion of market fee/HRDF Cess, the following inspection/ checking team are constituted for enforcement purpose: -

They are also directed that they should take assistance from the staff working in their jurisdiction and if they feel any additional requirement or change in staff, they should take approval from the Competent Authority. The other DMEOs whose name does not figure above should remain at the same station and keep checking their mandies and shall proceed further only as per direction from HQ for inspection/checking at given place.

1. The Teams will conduct checking in all the mandis of the area allotted to them to check whether all the arrivals and exit of Paddy, Cotton etc. are being recorded properly and there is no evasion of market fees.
2. They will also check whether permanent staff has been posted at all gates in the mandis and whether instructions dated 02.09.2015, 14.09.2015, 18.09.2015 and 22.09.2015 are being complied with or not.
3. The team will randomly check the trucks or other vehicles carrying agriculture produce on roads near the mandis and ensure that no evasion of market fee take place.
4. Further, both the ZMEOs (ZMEO Ambala & Hisar and ZMEO Rohtak & Gurgaon) are also directed to report directly to the H.Q.
