Subject:- Considering unutilized Government land for development projects before acquisition of private/non-Government land.

Sir/Madam,

As a welfare state, the Government of Haryana recognises that acquisition of land under the statutes and the alienation of landowners from their source of livelihood could be a painful process. Moreover, there is always a possibility of litigations which causes delay in acquisition of land. The past experiences of the Government releasing acquired lands point out the need for greater diligence in proposal for land acquisition.

2. Therefore, it has been decided by the Government that in future if any department/organization needs land for a project, it should first visit the website of Revenue & Disaster Management Department and check the availability unutilized chunks of land of different departments at the link <http://revenueharyana.gov.in>. If any chunk fulfils their requirement they will not acquire land of private landowners. The chosen land of any Departments can be transferred as per guidelines of the Standing Order No. 28 which is also available on the website of Revenue & Disaster Management Department at the link <http://revenueharyana.gov.in>.

These instructions may be brought to the notice of all concerned for strict compliance in letter and spirit.
