The HSAM Board a wholly owned Haryana State Government Organization invites Expression of Interest (EOI) from the dealers engaged in the trade / processing of Dry Fruits, Spices and Herbs in Haryana and Delhi, for providing 20% of its shops / booths to be carved out in the proposed Dry Fruits and Masala Market at Sersa in District Sonipat, Haryana. Such dealers are required to register themselves by paying a token money of Rs. 2,00,000/- (Two Lakh only) as registration fee along with processing fee of Rs. 5,000/- (Five Thousand Only). The detail of tentative Shops / Booths to be carved out in the proposed market is as under:-

After registration the potential dealers would become the preferential buyers for 20% of Shops in each category and they would be required to participate in the restricted auction starting from tentative reserve price. The Token Money of the successful bidders will be adjusted against the auction prices. The Token Money is refundable only if the applicant remains unsuccessful in process of restricted auction. In case of non participation in the auction process by the applicant, the token money / registration fees will be forfeited.

The eligibility criteria for being considered in the restricted auction are as under:-

Eligibility Criteria

1. Minimum 4 years of experience in Dry Fruits, Spices and Herbs Trade / Processing, continuously till the last season i.e. 2020-21 (Having Valid License/GST Number).
2. Minimum Average Turnover of trade valuing Rupees Fifty Lakh per Annum from Dry Fruits, Spices and Herbs Trade / Processing, during the last 3 years (duly verified by Chartered Accountant).

Submission of Expression of Interest:- The interested traders / dealers as specified in eligibility criteria may submit their Expression of Interest addressed to the Chief Administrator, Haryana State Agricultural Marketing Board, Mandi Bhawan, C-6, Sector-6, Panchkula, Haryana-134109 **OR** in the office of District Marketing Enforcement Officer, Sonipat, New Anaj Mandi, Rohtak Road, Near Kalupur, Sonipat, Haryana-131001 **by 20.12.2021 up to 3.00 PM** in the format at Annexure 'A'. Haryana State Agricultural Marketing Board reserves the right to reject or cancel any Expression of Interest without assigning any reason.
