The 13 July, 2005

No. 1519-Agri.S(1)-2005/ 10535 -In exercise of the powers conferred by sub-section (1) and clauses (xxviii), (xxix) and (xxx) of sub-section (2) of section 43 of the Punjab Agricultural Produce Markets Act, 1951 (Act 23 of 1961), the Governor of Haryana hereby makes the following rules further to amend the Haryana State Agricultural Marketing Board Service Rules, 1974, namely:-

1. (1) These rules may be called the Haryana State Agricultural Marketing Board Service (Amendment) Rules, 2005.

(2) They shall come into force on the date of publication in the Official Gazette.

2. In the Haryana State Agricultural Marketing Board Service Rules, 1974, in Appendix B against serial number 6, under column 5, for the existing entries, the following entries shall be substituted, namely:-

(a) By direct recruitment	40%
(b) By promotion (i) amongst Section Officer (JE)	40%
(ii) amongst Circle Head Draftsman	6.67%
(iii) amongst Section Officer (JE) possessing qualifications of Associate Member of Institute Engineers or BE	10.33%
(iv) amongst Assistant Draftsman possessing qualifications of Associate Member of Institute Engineers or BE	03%

Note 1:- In case suitable candidates are not available from source number (iii) and (iv) the vacancy shall be filled up by direct recruitment.

Note 2:- In case a candidate is not available from source number (a) or (ii) of source (b) and a person who has to be appointed in public interest as stop gap arrangement from other than allotted source such an official shall be liable to be reverted to his original cadre when a candidate from the allotted source is available and the period of service rendered by such person shall not be reckoned for the purpose of seniority."
