[Providing financial aid (ex-gratia) to cultivators for any injury or death during farming operations]

(Scheme)

ELIGIBILITY:

A farmer/ labour who met to an accident during the agricultural operations and not taken benefit under any other scheme of the State/ Centre Government in this regard.

BENEFITS PROVIDED:

Description:- The scheme was launched by the Hon'ble CM during the year 2013 with the aim to provide Financial Assistance to the Farmers/ Labourer who met to an accident during the Agricultural operations. The extent of financial aid under different circumstances is as under:-

Sr. No.	Description	Amount
1	Death	Rs5,00,000/-
2	Permanent disability due to breakage of back bone or otherwise	Rs.2,50,000/-
3	Amputation of two limbs/ permanent serious injury.	Rs.1,87,500/-
4	Permanent serious injury/ amputation of one limb (amputation of four fingers shall be deemed as loss of one limb)	Rs.1,25,000/-
5	Amputation of full finger	Rs.75,000/-
6	Partial Amputation of finger	Rs.37,500/-

DOCUMENTS REQUIRED:

- In case of Injury during agricultural operations where application submitted within/after two months of accident
 - i. Parivar Pehchan Patra
 - ii. Identity Proof i.e. Adhaar Card, PAN card, Driving License, Passport, Voter card (Any one of these).
 - iii. Request letter from the victim duly signed.
 - iv. Photograph of the applicant with injured limbed;
 - v. Affidavit/ undertaking in support of claim.
 - vi. Affidavit in support of claim by the owner of the land/ machinery in case of labour/ majdoor.
 - vii. Photocopy of OPD slip.
 - viii. Medical certificate.
- Death during agricultural operations where FSL report is required
 - i. Parivar Pehchan Patra.
 - ii. Identity Proof i.e. Adhaar Card, PAN card, Driving License, Passport, Voter card (Any one of these).
 - iii. Request letter from the claimant/ family member of the victim duly signed.
 - iv. Photograph of the victim.
 - v. Affidavit/ undertaking by the claimant in support of claim.
 - vi. Affidavit in support of claim by the owner of the land/ machinery in case of labour/ Majdoor.
 - vii. Copy of FIR/ DDR.
 - viii. Post-mortem report with reason of death (FSL/ visra report).
