

Krishak Uphar Yojna, 2019

Krishak Uphar Yojna was launched to encourage the farmer to bring all his surplus agri produce in the notified mandis and claim J-Forms from his arthiya. Further, to increase the business of commercial crops, the scheme was modified and it was felt that an incentive may be created for the farmer to claim J form on a regular basis from his arthiya, so that all the transactions of sale/purchase of agricultural produce are actually recorded. Therefore, some attractive prizes at the Market Committee level and some big prizes at the district level will be given to the farmers who succeed in the draw of lots of their gift coupons. These prizes are proposed for both the Rabi as well as Kharif seasons.

This scheme would be applicable on all MSP & non- MSP agricultural produce. Therefore, an incentive will be created for the farmer to actually get his sold crop recorded by claiming J-form from his arthiya.

The main features of this plan are:

- 1 This scheme will be applicable to all the crops of MSP and non-MSP, such as wheat, cumin, cotton, oilseeds, pulses, basmati paddy and other crops, whether they are being procured by the government or by private traders.
- 2 The farmer who sells his farm produce to the arthiyas and submit his J- form with concerned market committee will be eligible for the benefit in this scheme.
- 3 Before issuing the gifts coupons, the concerned Secretary, Market Committee will verify the sold agricultural produce with J-forms and with 'H' register.
4. Gift coupons for entry in the draw of lots will be issued to farmers in such a way that both the small and big farmers will be eligible for a prize. They may be issued as under:-
 - i) For a J form with value upto
Rs. 10,000/- of the agricultural produce sold. One Coupon
 - ii) For each multiple of Rs.10,000/- worth of crop sold, the gift coupon(s) will be issued in the same ratio i.e. for Rs. 10,000 two coupons, for Rs. 1.00 lac ten coupons and so on.
- 5 The three counter files of these coupons will be prepared. The main gift coupon will be given to the farmer. A counter file will be used for market committee level and for other state level draws. The third counterfoil will be in the Record of the Market Committee.
6. All the expenses incurred under this scheme will be borne by the HSAMB and HRDF Board in the ratio of 50:50 as approved by the Honorable Chief Minister, Haryana.

Other details:

The details of the **first phase (01.01.2019 to 30.06.2019 and second phase 01.07.2019 to 31.12.2019)** Details of the first phase gifts are given below and in the second phase, similar gifts will be distributed.

1. Under this scheme, 88 tractors and 88 tractor trolleys (4 in each district) will be given in the form of state-level gift.
2. Under this scheme, 150 happy seeders will be given only in the paddy mandis.
3. Under this scheme, 94 Rotavators will be given to only those mandis where the arrival of paddy is less or nil.
4. Under this scheme, 1422 cycles will be distributed on the basis of market committee income and category.
5. In addition, under the special scheme, in the form of first prize, 30 motorcycles (10 farmers, 10 arthiyas and 10 Officers related to market committee) will be given to those e-NAM mandis who will assist most farmers in getting online direct payment and as a second prize, 540 Bicycles (10 in each 54 e-NAM mandi) will be given to the staff of market committees who will assist more number of farmers in getting online direct payment.

Terms and Conditions for Draw Coupons

1. All types of "Draw" will be decided by the Chief Administrator, Haryana State Agricultural Marketing Board, Panchkula on the fixed place and date.
2. In this scheme, employees (board and committee) / artisan / merchant will not be able to avail the benefits of this scheme, only the gift to the farmers (which only works for agriculture) will be distributed.
3. This scheme is mainly for the farmers of Haryana state. Farmers should be permanent resident of Haryana and agricultural land must be in the state of Haryana.
4. If the farmers get more than one gift, then only one gift having more value will be given.
5. The numbers of the gift coupon and the names of the successful farmers will be written in the "Draw" register and the signature of the successful farmer will also be taken.
6. The successful farmer in the "Draw" of gifts, will have to claim his gifts by himself producing the coupon within 45 days of the result declared by the Board/ Market committees.
7. Under the scheme, farmers will be able to collect their gift coupon from the market committee within 7 days of receipt of 'J' form.
8. "J" form and main coupon should not be torn.

9. The 'DRAW' sub-committee will deal with any dispute raised related to the award at the market committee level.
10. Dispute related to the award at the state level will be settled by the Chief Administrator Board.
11. If there is a dispute on these coupons, then its legal jurisdiction will be only Panchkula Court.
12. Special rights to change the date of draw are with Haryana State Agricultural Marketing Board.
13. The right to increase or decrease the number of gifts is with Chief Administrator HSAM Board.
