**ORDER**

In compliance of orders dated 23.11.2023 passed by the Hon'ble Punjab and Haryana High Court in CWP No. 24716 of 2023 titled as Jagdish Chander Vs. State of Haryana & others and order dated 22.12.2023 passed by the Competent Authority, Sh. Jagdish Chander, Clerk, O/o the Executive Engineer, HSAM Board, Sirsa is deemed to have been promoted to the post of Clerk w.e.f. 02.09.2003, as SDC w.e.f. 18.09.2015 and as Assistant w.e.f. 29.06.2023 in the pay scales of Rs.3050-4590, Rs.9300-34800+3600GP & FPL-06 (Revised Pay Rules, 2016), respectively, the dates when his juniors were promoted subject to the following conditions:-

1. His deem date promotion will be on notional basis, the actual benefit of pay fixation will be given on actual date of joining on the above said posts.
2. On promotion, he will be on probation for a period of one year, further extendable as per rule.

7. His promotion is also further subject to the claims of officials of PWD category, if any, comes into the notice, if such justified cases is received, the relevant vacancy shall be given to the concerned PWD category officials and the official promoted against the said vacancies shall stand reverted without any notice or cause stated.
8. His promotion will be subject to the condition in SC category employees, if any Govt. instructions issued from time to time are also applicable on the promotion case and any direction of Govt. will also be implemented on the promotions and his promotions will be withdrawn without any notice in compliance of Govt. directions.
