region and where safety of construction of new building as well as existing buildings against earthquake hazards was also discussed. NCR, being in earthquake seismic zoning IV is highly vulnerable to earthquake hazards. It is, therefore, important that proper measures are taken as per codal provisions of relevant Indian Standards and adopt seismic retrofitting of buildings specially lifeline buildings. It was felt that engineers/architects of different Dept./ULBs, Govt. Undertakings who are responsible for building inventory need to be sensitized regarding earthquake resistant design and construction, seismic assessment/evaluation of buildings and its retrofitting.

Therefore, it was decided that Building Materials & Technology Promotion Council (BMPTC) in association with National Institute of Disaster management (NIDM) will organize two days Capacity Building Programme for Engineers and Architects with special emphasis on the problem being faced in the region. It has been decided to hold this Subject cited **Capacity Building Programme on 22nd - 23rd May, 2015 at Conference Hall, Haryana Regional Chapter (ITPI), Bay Site No. 59-62, Sector-2, Panchkula.**

There is no participation fee for attending the above programme. Expenses for food shall be borne by BMTPC. However, participants will have to make their own arrangement for stay.

It is, therefore, requested to nominate minimum three Officers (Engineers/ Architects/ Town Planners) of your Dept./organization to attend the workshop.
